Why Train in Right of Access/Release of Information?

Workforce compliance with federal and state privacy rules will help mitigate the risk of a HIPAA breach and lower the risk of a complaint filed with the Office for Civil Rights (OCR) triggering an investigation resulting in potential penalties, settlements or even criminal charges against your organization.

Who Should Take This Course?

Many workforce members have direct or indirect interactions with patients, caregivers, family members, payers and/or law enforcement. This course is designed for practice owners and administrators and is also perfect for front-line staff, such as medical office staff responsible for the release of information. Optional Certification Exam – Earn the Certified Right of Access Specialist (CRASSM) Credential

A remote certification exam by appointment with a professional proctor is available for an additional \$75 fee per attempt. A total of three (3) attempts at certification are permitted. You will be provided with details via email regarding the option to certify upon successful course completion. But should you certify?

Prerequisite to Certify

To qualify to certify, you must have at least 1 year of experience working for a HIPAA Covered Entity or an organization defined as a HIPAA Business Associate and be willing to earn Continuing Education Units (CEUs) annually to maintain your certification credential.

About the Certification Exam

- The exam is a 100-question, open-note, three (3)-hour proctored exam taken online
- Passing score is 80%
- There are four (4) domains:
 - Abbreviations, Terms, and Definitions
 - AI, Right of Access, and Information Blocking
 - Providing access, legal aspects of releasing information, and CMS requesting records
 - 42 CFR Part 2 and HIPAA Violations/Penalties
- Certification is approved by the Certification Exam Board

Maintaining Your CRASSM Credential

If you certify, you will need to maintain your credential by earning [CEUs annually](#) and paying the annual membership renewal fee. We do offer free and low-cost CEU programs for our members. For more information visit [Credential Renewal FAQs](#).
